Among these countries India , Bangladesh and Pakistan became major stakeholders by providing millions of freelancers in the field of freelancing. The best part of freelancing is that it is not gender-biased. Freelancing is equal opportunity for both male and female members of society. Traditional countries like Pakistan have a great opportunity in the form of freelancing in which the females of the country can take part at par with the men. It is estimated that, at present, around 100,000 "active" freelancers (who at least make \$100 a month) are working from Pakistan and earning valuable foreign exchange for the country. Keeping in view the importance of freelancing lancing the government of Pakistan has invested a lot in IT sector and , in the first seven months of the FY 2020-21 (July 2020 – January 2021), freelancers' export remittances have rapidly increased to US\$ 219 Million and are expected to cross US\$ 350 Million by the end of FY 2020-21.

In 2016, Pakistan recorded the highest unemployment rate in five years at 0.16%. While there was a decline of 0.14% in 2017 and an increase of 4.08% in 2018, unemployment peaked at 4.45% in 2019 (Heeks, 2017). The biggest economic downturn happened last year when the Covid virus strike the financial system and most people were either forced to work from home or quit their jobs due to downsizing (Hassan, Iqbal & Shakir, 2020). Thus, the trend of telecommuting is becoming popular among working men and women as well as the unemployed. Furthermore, women in Pakistan are not part of a large labor force due to social reasons. And follow the local model in the state. (Kaabi, Elanain & Ajmal, 2018). The main reason for not being truly jobless is the child and elderly care, limited job opportunities, lack of affordable kindergarten, and low levels of education (Kathuria, 2017). In the light of labor market and technological development, the study aims to analyze the impact of self-employment through market expansion and the capacity of the state to encourage women's participation in this platform (Graham & Anwar, 2019). Many researchers are primarily interested in the relationship between productivity, innovation, and performance respectively. In addition, the phase of the COVID pandemic has also affected the labor market, creating an urgent need for a source of work that provides access to remote work for individuals as well as a source of income (Nawaz, 2020).

In modern times, problems with the employment of graduates of higher education institutions are high. Future professionals start thinking about the workplace long before graduation. A retrospective analysis shows that 30-40 years ago there was a state distribution of graduates, although many graduates did not like, for example, the place of distribution, students were confident about their future work. In terms of the changes taking place in the country, the youth in the 21st century have more opportunities and ways to integrate into society, but this situation has created some obstacles in the way of employment.

Currently, every third unemployed youth has higher or secondary vocational education. Alumni guesses about their future jobs are correct about half the time. Young school leavers do not fully understand the relevant professional activity. In the educational process, more attention should be paid to the formation of ideas about their future profession according to the state of the labor market.

Freelancer - Freelancer - A term used for someone who has not worked fulltime for a particular employer for an extended time (Wood, 2018). Freelancers often offer their services on specific online resources, through newspaper advertisements, or through word of mouth, that is in-person interaction. Others work independently or use professional associations or websites to search for jobs (Primastomo, 2018). Self-employment also allows people to find high-level jobs in isolated communities.

#### LITERATURE REVIEW:

#### **Research Question:**

Why? Pakistan is a country having an average income in South Asia which has consistently unemployment among women and the young generation (Malik, Heeks, Masiero & Nicholson, 2020). The percentage of females is huge and they cannot join conventional jobs due to the constraints on workplace freedom and home responsibilities (Nawaz, Zhang, Mansoor **Hafeez & Ilmudeen, 2020).** Pakistan is developing having a 49% population of women and 29% are a young age. 63% population of Pakistan lives in rural areas of which the majority is youth (**asiapacific.unwomen.org**). The education trend in females is increasing in Pakistan 47% of women are literate whereas 70% are men (**statista.com**).

**Who?** Of the total human workforce, there is only 20% is female (**tradingeconomics.com**). These statists show that many women that are educated and have many skills are not working there are several reasons behind this like gender discrimination, family restrictions, harassment at the workplace, very low wages, transportation, relocation to job placement, and many more.

**When?** Now under this highly pressurized economical situation of the country, it is very difficult to survive on the earnings of one male. Now, this is the time for a woman to contribute to the earnings of their guardians.

**How?** But how can they contribute to the earnings? The answer to this question is freelancing. Now, why freelancing? Because freelancing has more independence of work, flexible timing, self-management, location flexibility, improvement in skills, rewards, and earning control.

For a few years government is taking remarkable steps and investing too much to build an online market parallel to the conventional business to manage the addition of women in the workforce, particularly in the Ministry for Information and Communication Technology. Freelancing normally offers work in the field of information technology for example online advertising and IT, financial services and accounting, customer support, managing projects, writing, software, web and application development, and graphic designing (Malik, Heeks, Masiero & Nicholson, 2020).

Many women do not have the skills to perform these tasks because these are different from our formal education (Nawaz, Zhang, Mansoor Hafeez & Ilmudeen, 2020). So the Government of Pakistan is proving so many free technical courses for a woman to resolve this problem. This was effective when 15,000 people started working as a freelancer, while another 500,000 people enrolled in this training program in 2020. As a result the chances of getting a job for a woman increase significantly. A survey shows its results that 25% of freelancers are a woman and doing a better job than men in Pakistan (Malik, Heeks, Masiero & Nicholson, 2020). Female freelancers earn \$2 greater than men in a day. Other than this government is trying to enhance the train and gain method to encourage the current IT business that will lead women to increase their earnings. In this way, Pakistan started freelancing and outsourcing with commercial capability enhancing digital technologies (Malik, Heeks, Masiero & Nicholson, 2020).

From a sales volume point of view, Pakistan is standing at 4<sup>th</sup> position in elancing internationally behind India, Bangladesh, and the USA (Ahmed, 2017). According to the freelancing.com website, 1 million Pakistanis are registered on their website which is at 3<sup>rd</sup> position in worldwide countries (Haq, Raja, Nousheen & Sajjad 2018; Iftikhar 2017). According to Upwork Pakistan is on the list of top 5 freelancer countries. Besides these freelancing websites Pakistani have proven their existence on social media also by creating a Facebook group named "Pakistan Freelancer" having 27000 members where customers can deal directly without using mediator freelancing websites. The IT division of Pakistan is contributing \$2.1 in the export of IT-related services and solutions per year. Upwork, Fiver, Freelancer, Guru, PeoplePerHour and Mylittlejob self-employee platforms are arising speedily in Pakistan. There are my factors and reasons that give me confidence someone for freelancing in Pakistan. Pakistani freelancers charge very low compared to India and South Asian countries but Pakistani freelancers are highly skilled that's why European countries prefer their outsource work to Pakistani freelancers (Codementor, 2017). PITB (Punjab Information and Technology Board) is a provincial institute in Punjab that provides free of cost pieces of training, courses, and workshops that are the base of freelancing. Particularly girls and housewives are participating in these events to earn money at home. Now a day's outsourcing is the trend. Companies prefer to give their projects on subcontracting to improve their work efficiency. Fiverr.com has 3.42 million active buyers. These are the job opportunities that motivate educated and uneducated Pakistani women who stay and want to generate or increase their earnings to start freelancing so they can meet their needs and full fill their dreams (Iftikhar, 2017).

For many years freelancing was taken as random work for unemployed people that cannot get traditional jobs and are disappointed. But in the past few years trends have changed, now in modern companies, many tasks and projects have been outsourced aimed to cut off the price and product quality. Now freelancers are trending and employers have much more confidence in them regarding their work (**Kuznetsova, 2018**).

Freelancing is consisting of very highly skilled and trained persons that are experts in their fields and provide their services to companies or individuals (**Bruke, 2012**). Freelancing is a bouquet of information technology that has a variety of blooms in it. Freelancing is a very emerging and recognized business these days that have great human energies to perform tasks and has much capital in reward.

Freelancing is providing many useful services to other businesses. Companies are working with freelancers more and more within a short time on a contract basis. Freelancers are the model of the modern labor market (**Bruke, 2012**). In addition, freelancers work in their homes with only their computer and internet connection (**Bogenhold et al, 2014**).

Moreover, society should be committed to empowering women. The empowerment beliefs of western countries contradict those of third world countries. Thus, women's empowerment can be measured by probing facts, assets, and circumstances. (Koshulko, 2021). Women in Pakistan are willing to compromise with their husbands on a range of issues, including profession, social mobility, employment status, girls' education, and family chores. However, disagreements lead to conflicts that reduce women's happiness (Qamar, 2021). As a result, compared to their male counterparts, women are less happy and satisfied with their families' real and perceived economic situation (Whitaker, 2021). In addition, many argue that feminists in Pakistan have expressed annoyance and frustration with their jobs. However, create your own business with the ultimate ambition of choosing the type of business, the hours, and the people you work with. However, most women have faced social, behavioral, and economic barriers throughout the life of the company. Freelancing is based on contract work, so there is no job security, maybe you get work further or not that is not sure (Nampewo, 2018). It's up to the contractor to restart the contract or not. Many freelancers earn a large amount in a single task and remain employees for the remaining whole month. Upworks' research says that about 63 percent of self-employed people see a lack of security as a major barrier to financing (Malik, Heeks, Masiero & Nich). Affirmative action and taxes are another constant with no guarantees. In a traditional job, the employer is responsible for health insurance including labor taxes, while workers bear these fees themselves. Hence there is no social security system (Gandini, 2016). It has advantages associated with global expansion and therefore more employment options,

which also means that competition among human resources, will increase. Consensus, and vice versa, leads to a potential decrease in revenue when each worker proposes projects (Malik, Heeks, Masiero & Nicholson, 2020).

In the conclusion, there is growing distressed about the decline in living standards as a result of this increasing type of employment. A study of 100 freelance workers showed that about 52 percent of remote workers feel alone and isolated (**Graham & Anwar, 2019**). This is because the virtual platform broadcasts the operating environment. Because individuals work almost without bartering their knowledge, the focus is not just on tasks and inputs. It has been estimated that workers who have just 15 minutes of socialization are 20 percent more dynamic (**Foong, Vincent, Hecht & Gerber, 2018**). This shows the significance of the social place of work. Additionally, the way companies view freelancers can be linked to feelings of exclusion. Since these labor costs are not fixed, contractors are motivated by the desire to complete the project and thus overlook the importance of the people completing the work (**Nampewo, 2018**).

Moreover, encourage women to become a freelancer and teach them which tools and techniques they can use to become successful freelancers.

# **HYPOTHESIS:**

#### **METHODOLOGY:**
