The good life of Hazrat Muhammad (PBUH) was a torch for all mankind until the Day of Judgment. The study routines of Hadith Karima reveal that the Holy Prophet (PBUH) divided his day and night into three parts. There are numerous wonderful examples of his initiatives for interfaith dialogue in his preaching style.<sup>7</sup> Another research paper we found on “Future Hopes of Interfaith Dialogue in Pakistani Context (Analysis of Dialogue in the Light of Muslim-Christian Scholarly Views)”, in this paper the authors said that the nations, religions and communities of today's world need more relationships, tolerance and peace than at any time in human history. As a result, interreligious dialogue has become a very important activity during this time of conflict. Many political parties, both religious and secular, have actively participated in it because of its importance.<sup>8</sup> Some other authors exposed their thoughts in this article entitled “Need of Interfaith Dialogue for Peace Building in Pakistan: An Approach of Madrasa Teachers in South Punjab”, in these words Interfaith exchange is acquiring worldwide consideration as a developing cultural need and peacebuilding instrument in light of intolerance and conflict.
