Abstract

The absence of the universe is the greatest possible evidence that shows it has been created. This fact is kept in view, many things change. This helps people to know the meaning of life and to review their own visions and objectives. That is why many scientists have tried to ignore the reality of the creation that they could not fully understand, although the evidence was clear to them. Because of this fact, many scientists had to invent alternatives to make people's minds proud so that they could take their minds away from

the fact that there was scientific evidence to prove the presence of a creator, but it itself draw a line on these scientific theories. Which will be described in this article.

What is Science?The knowledge of the discovery of the rules and regulations of The Divine Power in the physical world is defined as science. The word 'science' is a Latin word meaning 'knowing' or 'knowledge'.¹

In simple and short terms, it means experimental sciences and wisdom. If further explained, it is a regular knowledge of natural or physical phenomena or a truth as determined by observation, experience or perseverance logic. In other words, it is the knowledge of physical facts that comes from observation and experience. The scope of science is related to materialism, while religion also includes issues that are excluded from science and philosophy. In science, issues are discussed with material and in philosophy, estimates are discussed.²

Religion covers all the sciences and factors in addition to the subjects involved in these two sciences, which are covered in the scope of all the subjects of the worldly and ultimate one-divine religion, in addition to the present universe material, the sciences of post-physics, and the ology of life or post-life. Thus science laws know the discovery of nature and awareness of facts while the source of the teachings of Islam conveys the message of finding and thinking of facts in the Qur'an and worldly sciences. Scientific laws are the name of the discovery of nature which is preserved in an unchanging form in the universe. Therefore, science demands reality, authenticity and religion. He is not stubborn and hostile. How much the Qur'an inspired man towards science and knowledge of the universe, and how strongly he drew attention to the laws of nature that are visible and present in the universe, and that attention created numerous scientists among Muslims. Science requires that the laws that they have established within the universe, based on god's belief, are the laws that the Universe has placed in the universe, and in their minds the same God has also placed the power of mind and thought to discover these laws from experience and experience and use them for useful purposes. The universe or the material universe is not the originator of these laws, but it is the manifestation and manifestation of these laws. So we see the essence of this balance of the universe everywhere, from our body to the vast vision and the range of vision, there must be some master. The question arises: Who is the Creator who commanded everything in this universe to come into existence with such a sophisticated and fine bind and created it ? He certainly cannot be a material creator within the universe, because his self must exist before the universe comes into existence, which has created with its own will and intention. The Creator is the great one in which everything in which he exists, and who has no beginning or end of his own self. Religion teaches us the identity of our Creator, whose presence we discover by our own reasoning. Through what he has shown us in the form of religion, we know that he is Allah, the Most Merciful and the Merciful, who gave existence to the heavens and the earth from non-existence. Indeed some people are capable of reaching this fact easily, but they spend their whole lives unaware of it. Whenever they see a beautiful scene in the form of a picture made of a mixture of colors, they start wondering who its painter is?. Then, upon being found out, he praises the painter, the creator of this beautiful work of art. Despite the fact that there are numerous images in the form of original, natural landscapes of this picture, but despite looking back at all of them, they ignore the presence of Allah's

self, who alone owns all these beauty and beauty. In fact, no long research is necessary to understand the self of Allah. If a person is alone in the same room from birth to the end, the small world inside this room will be enough for him to understand that Allah has his own self. The evidence and evidence within the human body itself is so accumulated that it will not even be in an encyclopedia containing many volumes. If anyone can give him even a few minutes for consideration, it is enough to assure him that Allah exists. The present system is in the protection of Allah, and he is keeping it intact. Not only does the human body make a window of thought for man, but life resides in every square millimeter of the earth. Whether it comes to mankind or not. There is an ocean of animals in this world, from a cellular molecule to plants, from insects to marine animals and from birds to humans. If you take a handful of clay and look closely at it, you will also see within it a variety of organisms that have different qualities in themselves. The same is true of the air in which you breathe, even on the skin on your body, there are many organisms whose names you are not even aware of. All living organisms have millions of germs or single cell molecules that help in digestion. The number of animals in the world is many more than the number of humans. When we consider the world of plants, we find that there is not a single place on this planet where life does not exist. All these creatures, spread over an area of millions of square kilometers, have different bodies, have different lives and play a different role in maintaining geological balance. It seems remote to claim that all of them have come into existence without any purpose or purpose, or that any living thing in the world has come into existence on its own or by its own effort, and any incident or incident can come to light within such complex systems. This evidence leads us to the conclusion that the universe is created under a particular 'consciousness and awareness'.

The question arises: What is the source and source of this awareness? Surely it can be none of the living beings or lifeless creatures that live within it. This is reviewed below.

From non-existence to universe, A review: These questions have always been topics of interest as to how this universe came into existence, in what direction it is moving, and what are its systems and balance-keeping laws?. Scientists and thinkers have come up with a few theories after a great thought on the subject. Until the twentieth century, it was commonly believed that the universe had unlimited expanses and it has been since time immemorial and will continue to exist. According to this theory, which was called 'eugenics-unchangeable universe model', this universe had neither the beginning nor the end. By paving the ground for materialistic philosophy, this theory denied the existence of the Creator and presented the notion that the universe was a permanent, stable and unchanging set of matter.³

Materialism is a system of thought that considers matter to be a permanent object and denies everything except matter. As mentioned at the outset, the model of this eugenics non-variable universe had paved the earth for the philosophy of materialism in the nineteenth century.⁴

The one who George Polisser writes in his book about the basis of the model of this universe is as follows:

"This universe was not a created item. He added: "This universe is not a creation, because if it had been, God would have created it and made it come and made it non-existent. In the first stage of recognition of

creation, you must recognize the existence of the moment when the universe did not exist. And then there is the fact that something has come into existence that science does not believe".⁵

When Polaris claimed that the universe was not created from non-existence, it was actually relying on the model of the static and immutable universe of the 19th century. He came across the idea that he was making a scientific claim. However, the developing science and technology of the 20th century had rejected such ancient theories that the model of the eugenics non-variable universe had paved the earth for materialists. Today, when the 21st century began, modern physicians have proved through many experiments, observations and experiments that this universe had a beginning and created it in a non-existent manner with a huge explosion. Went.

The beginning of the universe means that this world was created from non-house, that is, it was created. If a created object exists (which did not exist before), then it must have a creator. What comes from non-existence does not come to the human mind (man cannot understand it in practice because he has never been through such experience) so coming into existence from non-existence is a very different thing than combining different things to create a new object. For the objects created (e.g. art patterns or artistic inventions), Allah's sign is that everything was created in a sudden and comprehensive form in a moment. There were no earlier examples of these created objects, no existence of time and space in which they could be created.

The existence of the universe from non-existence is the greatest possible evidence that shows that it has been created. Considering this fact, many things change. This helps people to know the meaning of life and to reconsider their attitudes and objectives. That is why many scientists have tried to ignore the reality of this creation, which they could not fully understand, although the evidence was clear to them. Because of this fact, many scientists had to invent alternatives to pollinate people's minds so that they could take their minds away from the fact that there is scientific evidence to prove the presence of a creator, but it itself draws a letter on these scientific theories. Let's take a closer look at this scientific progress on how this universe came into existence and how it set evolutionary stages?

Scientific review of the evolution universe: If you think about the structure, creation, evolution and expansion of the vast universe, the earth, the sun, the stars and the planets are merely small points in the universe. Our sun is a galaxy that consists of one trillion stars and billions of galaxies like it are also found. The remotest bodies of other galaxies known so far are located about 16 billion light years away from us. Their rays Radiation had begun their journey not only before the earth but perhaps even before the creation of our galaxy. The closest star to us after the sun is 'Proxima Century' is located at a distance of about 4 light years.⁶

That is, its light spends more than 4 years reaching us. Our sun is 8 light minutes away from us (i.e., its light reaches us in 8 minutes). Most stars that are able to be seen with the naked eye are located several hundred light years away.

Our investigation into the vastness of the universe is not more ancient than 1929, when Edwin Hubble an astronomer, revealed that our galaxy is not the only one. There are many

other galaxies in the universe leaving vast areas empty between them, moving in the opposite direction of each other in such a way that their speed increases as the distance increases. It appears that with the spread of galaxies, the whole universe has also expanded, and the distance between the galaxies is constantly widening.

Dr. Hubble discovered this secret of the expansion of the universe through comparisons with the galaxies of the Red Shift. It proved the accuracy of the ever-increasing distances through the 'Law Hubble' and the true rate of spread, known as Hubble's non-variable principle (Hubble's constant). This discovery is one of the great conscious revolutions of the twentieth century. Now they are able to determine the current rate of spread of the universe and galaxies through the 'Doppler Effect. We are now aware of the fact that the universe is expanding at a rate of 5 to 10% every one billion years.⁷

It is surprising for the seekers of reality that 14 centuries ago, when the theory of the universe's immobility was accepted all over the world, how the Qur'an informed humanity of this modern theory of astronomy (Astrophysics) and the creations of the universe (Cosmology), while the theory of the stagnation of the universe was so stable that it was so stable all over the world until the early twentieth century. Has been recognized as undeniable reality.⁸

Newton's law of law in the spread of the universe could not even access reality. Even The Constitution of Satin, when he presented his general theory of addition in 1915, had such a strong belief in the theory of stagnation that he changed his ideology as much as possible by introducing the famous world 'Konya permanent' (Cosmological Constant) in the equation of this theory.

In fact, Russian physician and mathematician Alexander Friedman (Alexander Friedman) was the man who first presented the hypothesis of the expansion of the universe in 1922, which was later nurtured on scientific grounds by Edwin Hubble and eventually proved by two American physicians, Arno PansYes (Arno Penzias) and Robert Wilson (Robert Wilson) in 1965. The two scientists worked at the Belfone Laboratories (Bell Labs) in New Jersey, U.S.A., who were also awarded the Nobel Prize in 1978. ⁹

After centuries of research, modern knowledge creations the universe (Cosmology) astronomy (Astronomy) and astronomy (Astrophysics) have presented exactly the same theory that the universe was created by a 'unit of zero rank size'. The theory of great explosion (Big Bang) is a reasonable interpretation of it.

It has to be remembered that all history of science consists of a step-by-step quest to access reality, in which the world of history does not automatically perform, but reflects a real phenomenon that is created and activated by the other.

There are many standards of theories related to the universe that explain the various early stages of its beginning. But they do lead to the initial state of Zero Volume Singularity Infinite Density all of them, such as:

- 1-Friedman's sketch (Friedman Model)
- 2-great explosion Outline (Big Bang Model)
- 3-Edwin Hubble's Sketch (Edwin Hubble's Model)

- 4-Panzias and Wilson's Sketch (Penzias Wilson's Model)
- 5-New Expansion Outline (New Inflationary Model)
- 6-Disordered Spread Outline of (Chaotic Inflationary Model)

Or

- 7. The profile of the custody of unit (Singularity Theorems Model)

the latter was proved by Roger Penrose and Stephen Hawking. 10

The theory of great explosion (Theory of Big Bang): In 1687, the famous British scientist Isaac Newton presented the cosmic concept of gravitation and said: The universe is static and non variable 'The universe is static and immutable'.

In 1915 Albert Einstein presented the general 'theory of addition', which explained the correlation between matter, energy, attraction, mass and time. He somewhat rejected the concept of 'Newton' as 'stagnant universe', but he himself was unable to give a new theory about the origin of the universe.

This was in 1929, when Edwin Hubble, an astronomer at the California Wilson Observatory, made a great discovery in history of astronomy. While he was observing the stars from a huge telescope, he saw that the light emanating from these stars shifted to the red edge of the Spectrum and the light was very prominently seen from the earth. This discovery had a lightning effect on the world of science. This was because according to the accepted principles of medicine, the waves (Spectra) of the light-radiation, which were travelling towards the point of observation, had become red-inclined. During Edwin Hubble's observations, the star-bursting light was discovered to be getting headline-oriented. It meant that they were constantly moving away from us. 11

Hubble soon made another very important discovery:

"Stars and galaxies are not only getting away from us, but their distance is also increasing. The universe in which everything moves away from each other can only result in the continuous expansion of the universe' . '12

Albert Einstein, considered to be the greatest man of his century, came to the conclusion after various reviews in theoretical physics that :

The universe is not static and non-variable' '13

'This universe cannot be unchanged'.

However, he buried his discovery simply because he did not want to contradict the broad view of his covenant that the universe static was an immutable model. Einstein later had to admit that his act was the 'biggest mistake of the professional sector'. After all, Hubble's discoveries had finally convinced that the universe was expanding and that it was not variable. The question arises, then, the fact that the existence of the universe is of importance in terms of the universe that the universe is expanding? The expansion of the universe meant that whenever it travelled backwards, the universe proves that it came into existence from a single point.

These reviews indicated that this 'single point' that had sheltered all matter in the universe should have had a 'zero volume' and 'infinite density'. This universe came into existence with the explosion of this single point, the great explosion of the point of which the journey was volume was called the Big Bang (Big Bang) which started the universe. And this pattern was also named after this name.

It is important to explain that 'zero volume' is a theoretical expression used to interpret the subject. Science can interpret the concept of 'non' which is beyond the limits of human understanding and can only be represented through the expression 'with a point zero volume'. In fact, 'one point without volume' means 'none'. And it was from this that this universe came into being. In other words, it has been created.

'The model of the universe presented by modern science through telescopes has seen long distances between different galaxies. It also appears that they are somewhat inclined towards the headline. The line shown at the top indicates a certain point on the spectrum. In the second tiuf, this point is tilted to the right which reaches the horizontal part. Tilt towards the heading which shows the distance, as the galaxies move away from the earth, the distance between them increases.14

The Big Bang theory revealed that at the time of the beginning of The earth and sky, all the things in the universe were interlinked which were then separated. In this regard, Edwin Hubble (Edwin Hubble) also presented for the first time the assumption based on his fact that:

'The universe is not static and non-variable'

The universe is not static and immutable, but it is also expanding continuously. Its research gave rise to the theory of 'great explosion' (Big Bang Theory). The theory of the great explosion was initially nurtured by 'Martin Relay' and 'Allan R. as an excellent and reasonable interpretation of the creation universe.15

In 1965 two American scientists Arno Penziasand Robert Wilson discovered the 'ray of cosmic background' (Cosmic Background Radiation) and proved that the physical universe began with one unit. He named it 'Short Cosmic Egg which had immense energy within itself. He suddenly burst and as a result found the creation of different types of matter of the universe and later different galaxies were created.16

Four basic forces that exist in their own functions of different heavenly bodies also came into existence with it. These are the strengths.

- Gravity
- Electromagnetism
- Strong Nuclear Forces
- Weak Nuclear Power

According to scientists, 15 billion years have passed since this universe was created. What was before this initial mass unit, which created this universe in the form of an explosion?

Science in this regard informs us that immense energy had bound the universe in the form of an early mass at that time. It was suddenly an unimaginably difficult and hot place called 'unit'. At that time the density of the universe and the Curvature of space time were infinite. The universe is believed to have zero size. This condition of unit and zero degree is directed towards size (Zero Volume). After this phase the process of sprouting and spreading started.

Which Edwin Hubble describes as this?

"With the start of the Big Bang process, in the hundredth part of a second, it spread to the 'Aqita' and became the primary fireball, and immediately after the explosion its temperature reached a level of 80 billion degrees. A minute after the explosion, the universe's temperature dropped between 10 billion and 18 billion degrees. It was about a thousand times more than the current temperature of the sun center. At that time, the universe was mostly composed of photons, electrons, neutrinos and its opposite particles, as well as some extent of the proton and neutron"¹⁷

With the start of the great blast (Big Bang) process, in the 100th of a second, it spread to the 'unit' to become the initial fire ball (Primordial Fireball), and immediately after the blast, its temperature went up from one trillion to one trillion 80 billion Celsius. A minute after the explosion, the temperature of the universe dropped to between 10 billion and 18 billion Celsius. It was about 1,000 times higher than the current temperature of the sun's center. At that time, the universe consisted mostly of photons, electrons, neutrinos and its opposite particles, as well as somewhat protons and neutrons.

This first stage of the universe was first portrayed by a scientist named George Gamow in his famous writing written in 1948. He said:

'After the Big Bang, the universe was so hot that nuclear thermal radiation could be introduced everywhere.'¹⁸

After the great explosion (Big Bang), the universe was so hot that 'new-key thermal interactions' (Thermonuclear Radiation) could begin everywhere.

This meant that the early universe was more energetic than the high energy edible moji (Short Wave) fountains. He made a valuable prediction that the radiation (Radiation) found in the form of fountains in the early extremely hot conditions of the universe should still be released, but with its low temperature which is only a few degrees above absolute zero (270-C), this radiation was later discovered by Panzeas and Wilson in 1965. As the universe continues to expand, its temperature is falling. Currently, the average temperature of the universe has dropped to 270-C, just 3 degrees above absolute zero 273 C. This is the temperature where all movements of molecules are frozen.

George Lawaitre pointed out in 1931 that if the spread outside all galaxies is pursued, considering the facts hidden in it, it is plausible that they will all come back to the point from where the journey started, this large drop of matter known as 'early atom'(Primeval Atom) or 'cosmic egg'. Of course, what was found in the distant past as the physical universe will surely happen?Lawaitreassumptiond:

"The big drop of the material exploded for some reason and went out like a bomb. This is the creation of the universe'.¹⁹

Lotter's idea was later introduced as the theory of great explosion. There is a difference of opinion here as to how the substance consisting of zero-grade size unit was divided, how the female travelled on the outer side and how the separation, fission and explosion started?

The real reality is that the galaxies seen today are fissioned and separated from the unit matter that was connected in the form of a unit (Singularity) and then they were separated by a loud explosion.

Research of alternative forms of the Big Bang theory:

The theory of Big Bang made it very clear that this universe was created from 'None'. For this reason, astronomers who were deeply associated with materialistic philosophy continued to oppose the Big Bang theory. And held on to the theory of the gradual coming of the universe. A.S. Edington, the leading materialistic physician, explained the reason for this effort in the following words: I never liked the sudden beginning of the universe from the philosophical point of view. I never liked the sudden beginning of the universe from the philosophical point of²⁰

Sir Fred Hail was one of those who was upset with the Big Bang theory. In the middle of the century, Hail gradually tried to make public the theory of the existence of the universe, more or less similar to the 19th century 'Non-Variable' theory. The theory of the universe gradually coming into existence argued that the universe was endless in volume and chronic over time. The only purpose seems to be support for materialistic philosophers. This theory was completely contrary to the 'Big Bang' theory, which is the beginning of this universe.

Those who supported the idea of the universe gradually coming into existence opposed the Big Bang for a long time. But science was working against them.

On the other hand, some scientists were looking for alternative forms.

It was in 1948 that George Groom presented another concept related to the Big Bang. He said,

'After an explosion, the universe should have been a little more in the universe that was formed by the explosion. Moreover, this extra-large should have been equally spread across the universe. This evidence should have existed, it was left to be found soon'.²¹

In 1989 NASA sent 'CUBE' satellite into space to research the background of radiation in the universe. It took just eight minutes for the satellite to verify the 'Penzias' and Wilson measurements through its sensitive devices. 'CUBE' had discovered the remains of the great explosion that took place at the beginning of the universe. ²²

It was described as the greatest astronomical discovery of all times. After the Kobe satellite, the CUBE-2 satellite had also confirmed the Big Bang based reviews.

Another important evidence of the Big Bang (Big Bang) was the amount of hydrogen (Hydrogen) and helium (Helium) in space. In the last reviews, it was also found that the concentration of hydrogen and helium in the universe was consistent with theoretical reviews of the concentration of hydrogen, helium, which survives the Big Bang. If this universe had not had a beginning and existed since time immemorial, the composition component of the hydrogen would have been completely spent and converted into helium.

All these were reassuring evidences that persuaded scientists to accept the Big Bang theory. The Big Bang model was the last point at which science had reached the theory of the formation and origin of the universe.

Fred Hail' defended the theory of the universe for years Dennis Sciama mentioned the final situation when all the evidence in favour of the Big Bang theory had come to light. He said that:

"He was a supporter of the theory of teaching and was involved in heated debates. Those who had experienced this theory merely with the idea that they expected it to be rejected. He continued, "He was not defending the teaching theory because he recognized it correctly, but he wanted it to be corrected"²³

As objections came against this ideology, Fred Hail fought them all. Sciama says that at first he also supported Hail but when the evidence started gathering he had to admit that the game was over now. And now the theory of gradual ness should be dismissed.

Professor George Abel (George Able), who is from the University of California says:

'The evidence that was present at that time revealed that, this universe came into existence with a billions of years ago'.²⁴

With the victory and victory of the Big Bang (Big Bang), the theory of 'chronic matter' which gave the foundation to materialistic philosophy has been thrown on to the garbage dump of history. The question arises as to what was before the Big Bang. And what was the power that brought this universe into existence with a big explosion when it 'didn't exist'?

This question certainly refers to Arthur Edington Arthur Edington's words:

"This fact is philosophically unacceptable to the materialists' that a creator must exist"²⁵

The famous atheist philosopher Antony Philip comments on this issue as follows: "It is well known that the confession is good for human beings. I will therefore begin my talk with the belief that Stratonicism should be disturbed by the contemporary cosmic pluralism, as it seems as if the astronomers are presenting a scientific evidence to the universe, which is based on the St. Thomas philosophy. Could. That is, it is the beginning of the universe until it is conceived with great satisfaction, so one day it is to come to an end. But there is also a beginning. Until then, it seems easy to accept the existence of the universe and the particles that make up its creator as the ultimate explanation. I believe that this is still true and true. But it is certainly not easy to maintain that belief in the presence of the Big Bang story'.²⁶

And then many scientists who do not hold themselves within the atheism of disbelief without thinking admit that the Creator of this universe must be. The Creator can be a being who has created both matter and time, free and beyond both.

A renowned astronomer, The Hug Ross expresses the fact:

'If time begins with the universe as space is called, then the reason for the existence of this universe must be a space that is working within a time period with complete freedom and which is the time of the universe. Be free from, and already exist. This conclusion is very important for our understanding of who God is and who is not. It tells us that the universe is not God himself, nor is it limited to the universe.'²⁷

Non-existence of matter (Atom): This observation of astronomical medicine (Astrophysics) is the result of the Law of Uncertainty (Uncertainly Principle) of Heisenberg. When all of the electrons lost all their energy due to the uncertainty of so many events, it continued to disintegrate with leadership, thus applying to space. If these zero-place variations (Zero Point Fluctuations) are followed, they will be able to grieve the giant amount of energy, which may be considered borrowed energy from another place in the universe. As a result, this borrowed energy can sometimes produce a particle. And later it may be destroyed immediately.

This concept which defines general consciousness was first presented by the physician ' Hendrick Casimir in 1948. The presence of these particles was also revealed in 1948 by an American physician, Willis Lamp (Willis Lamp). ²⁸

Recently, Professor of Medicine Paul Davies (Paul Davies) boldly announced that:

"The absence of new material is an important proof of the power of Allah lord of honor. These modern ideas add to our understanding of the Big Bang Theory and the unseen nature of Allah. However, it is seen that the Maher-ul-Aqul blast was a cause of the universe and according to this the physical structure of the universe and the existence of stars and galaxies came into existence. According to the latest data, the first phase of the giant-scale explosion was completed in a billion seconds, when the matter that gave birth to galaxies and stars was connected. The first innovation took place in the one thousandth second of a second".²⁹

From this cosmic fission, a scientific estimate, Ten Billion Second (1000000000000000000)

What happened after the great blast (Big Bang)? Stephen Hawking (Stephen Hawking) According to a great physician:

"The Big Bang only a few hours later, helium and other elements were expanded, and the universe continued to spread without any significant accident for the next several hundred thousand years. Then once the average temperature of the universe dropped to a few thousand degrees, the electrons and the nucleus could not retain enough energy to overcome the electromagnetic attraction between them, so they had to create atoms in the space of a few seconds".³⁰

The entire universe as a whole is believed to be continuing to expand and cool down, but in areas that are relatively dense, the process of expansion has slowed down due to greater gravity. Finally, this led to the expansion of the universe in some areas, and during the demolition again, the gravity of the matter outside of the particular circles from where the demolition would begin may begin to rotate them slowly. As the collapsed circles become smaller. Their roaming will continue to pick up. Eventually, when a circle is too small, it will rotate so fast that it will not be able to maintain the balance of gravity. Orbiting galaxies (Spiral Galaxies) were born in the same manner. Other galaxies in which this process of axis rotation did not appear. They continued to take oval form, they are called oval galaxies (Elliptical Galaxies).

Galaxies begin to produce some heavy compounds towards the end edges of the stars, which are filled with gas and provide raw materials for the birth of new stars. New ones are formed in this way.

Roger Penrose, A physician has done extensive research on the origin of the universe. He writes:

'It is true that the universe is not just here by coincidence, but it certainly has a purpose. Some people think the universe is just where it is, and it will stay there. We find ourselves in the middle of this whole thing. This approach will probably not help us understand this universe'.³¹

In Penrose's view, there are many deep eras' ingestions in the universe that we do not understand today. Indeed, the thoughts of this physician help us to promote our thoughts. Many people have wrong ideas who believe that this universe exists without purpose despite all its perfect harmony. And their lives in this world are nothing but sports, but in the presence of the very perfect and wonderful order that came into existence after the Big Bang, it cannot be considered a normal or ordinary universe. The poem found in the structure of the atom rules the whole universe. With the atom and its particles moving in a certain order, the mountains are not dispersed, the dry has not been broken, the sky has not burst and in short the matter is kept together which is immutable.

Ruling countless human beings for centuries and presenting themselves in the veil of 'science', materialism spoke of the existence of the object only and only by substance. It was his great mistake that he denied the existence of Allah, who created the substance, gave him an order and gave him the existence of non-existence. There will come a day when materialism will be known in history as an ancient and superstitious belief that opposes both reasoning and science.
